Dear Parents and Carers,

As we enter the festive season and term 2 draws to a close, I wanted to write and draw to your attention some key information the safeguarding and inclusion team feels is important to share.

Travelling in the local community

With the colder darker evenings, we are seeing an increase in students taking 'shortcuts' travelling to and from the Academy and at other times. It is important for young people to always ensure that they travel along pathways which are well-lit and where there are others around. We recommend that none of our young people travel alone, and they should always travel with friends or family.

We have a small number of young people who also travel by bicycle or scooter. We recently celebrated road safety awareness week in the Academy. Students participated in activities which reminded them of key information on this topic. I would like to take this opportunity to remind you of some of the key information covered and would appreciate it if you could also have these conversations at home.

- Always wear a helmet
- Always wear high-visibility clothing
- Remain central to the road and away from gutters / parked cars
- Remain aware of surroundings avoid wearing headphones which restrict the sense of sound
- Don't cycle on pavements
- Lights and reflectors on the front and rear of the bicycle
- Ensure all valuables such as mobile phones are out of sight when travelling to and from school









Smoothwall – Online iPad Monitoring

You will be aware from our recent communications that as an Academy our responsibility for filtering and monitoring extends to all Academy devices both inside and outside the Academy. This includes when school-issued iPads are being used at home.

Smoothwall is industry-leading software which we have purchased and installed to support with safeguarding our young people online. All students must be aware that their usage is monitored 24 hours a day 7 days a week and breaches of the Acceptable User Policy will lead to sanctions being put in place by the Academy.

Online Safety

Christmas is a time when lots of our young people receive devices that can access social media such as tablets, smartphones, game consoles and laptops.

We're delighted to let you know that Brompton Academy has become a member of The National College – a multi-award-winning online training provider for staff and parents. As part of our membership, The National College provides dedicated training and resources for parents and carers – particularly around online safety and keeping children safe online. Of course, staff will continue to teach children about the risks online. But with the internet so readily accessible, the most effective approach to online safety needs everyone involved, including parents and carers.
